**QR NETWORK'S 2010 DRAFT ACCESS UNDERTAKING - ADDENDUM**


I refer to the QR Network's draft 2010 Access Undertaking (Revised DAU) that was lodged with the Queensland Competition Authority on 23 September 2010.
