Dear Mr Parmenter

I am writing to advise you on the assets associated with the bulk water supply service as referred to in the Ministerial Referral Notice of 19 March 2010 (the direction). These assets will constitute the bulk water supply and are to be considered by the Queensland Competition Authority (QCA) in its assessment of the opening regulatory asset base on 1 July 2011 as per the policy parameters under Section 1.4 (b) of the referral.

I understand that the QCA, in discussions with the Department of Environment and Resource Management, sought clarification that, for the purpose of the referral, assets associated with the bulk water supply be defined as: *infrastructure associated with the storage of large quantities of water, which is used to supplement water access entitlements and are described in, and regulated under the ROLs and IROLs.* 

The QCA's interpretation results in a list of storage assets such as dams, weirs, barrages and off-stream storages being defined as bulk assets as per Attachments 1 and 2, which is the intended definition.

The proposed definition does not include ancillary assets which perform water distribution functions either for bulk (river and groundwater access entitlements) or channel irrigators.

For the purpose of this referral, all ancillary assets used in the distribution of bulk water are to be valued at zero. This includes in-stream pump stations, gauging stations and bulk channels. This aligns with the Government's policy intent, for the purpose of setting irrigation water prices, that channel distribution systems be valued at zero as set out in the referral.

There is one point of clarification in the application of this definition which I would like to make. The QCA has not been requested to recommend prices for water services provided by Burnett Water Pty Ltd and, therefore, for the purposes of this referral, the assets of Burnett Water Pty Ltd (that is, Paradise Dam and Kirar Weir) are not to be included in this review.
