ESTIMATED FLOOD DAMAGE

Further to my letter of 8 March 2011, I am able to provide some more details of the damage caused to SunWater's assets by the recent floods. As mentioned previously, the full extent of the damage cannot be determined until thorough assessments are undertaken and in some cases until elevated river levels return to normal levels.

SunWater currently estimates that damage to be in the vicinity of \$6.5m state wide, although this figure could rise to closer to \$10m once all schemes are able to be fully inspected. The table below provides a short description of the damage and estimated costs by service contract for damage contributing to the current \$6.5m estimate. The estimate is based on information at hand on 7 March 2011 and recent rainfall events in Far North Queensland have not been assessed.
