On behalf of the Mt Larcom & District Show Society, I wish to express great concern for what we believe will be the future cost of reticulated water in the township of Mt Larcom.

The Mt Larcom & District Show Society Inc is a non-profit body, run entirely by volunteers for the benefit of the community of Mt Larcom. In recent times we have been struggling to meet the increased cost of Public Liability insurance and the proposed cost increases to our water supply could mean that our society will cease to exist.

Mt Larcom hosts the ONLY agricultural show in the Calliope Shire and maintains and upgrades the only public land facility in the Mt Larcom District. The grounds are used by the Show Society to host the following activities:

- The annual Agricultural Show
- The annual Mt Larcom Rodeo
- The annual Mt Larcom Progressive Dinner
- Monthly meetings

The following groups have facilities on our grounds:

Although the Showgrounds does have a small dam, it would be highly impracticable and financially impossible to disconnect the town water and set up the necessary infrastructure to operate from the existing dam. We also have serious concerns about the safety of an open dam.

Using the proposed water cost increase to determine a projection of costs, out water costs would rise from the current cost of \$810.44 (which we paid in November 2004) to somewhere in the vicinity of \$12,000.00.

It is well known that the cost of Public Liability Insurance has meant the demise of many non-profit community groups. At the present time, our members work every Saturday afternoon at the local hotel running Goose Club raffles. The money raised by these raffles goes solely towards paying the cost of our Public Liability Insurance. (Currently in the vicinity of \$7,000.00 per year.) It is not possible for the Show Society's volunteers to work (and the community to support) further fundraising ventures that would raise another \$12,000.00 to pay for water. Just as we cannot run without Public Liability Insurance, we cannot run without water.

On behalf of the Society and the community of Mt Larcom I would ask that this matter be given further serious consideration. Our Society provides a vital service to the community of Mt Larcom and needs to be allowed to remain viable.
